

## Innovating Dance Practice Grant Guidelines

The Innovating Dance Practice grant is an initiative of Ausdance NSW to assist professional dance practitioners residing in NSW to develop and innovate their practice through funds made available by Create NSW on behalf of the NSW Government. This is year two of a three year initiative.

The grant provides assistance to realise an opportunity that inspires new work, knowledge and skills, for example:

- program of activity that develops your professional practice
- secondment with an organisation
- mentorship with an individual
- residencies involving innovative approaches to your working practice.

Your proposal must engage with at least one of the following [Create NSW, Arts and Cultural Development Program \(ACDP\) priorities](#):

- people with disability
- young people
- Aboriginal people
- people from culturally and linguistically diverse backgrounds
- people living and/or working in regional NSW
- people living and/or working in Western Sydney.

Funds can be used to cover any costs associated with your activities, such as, artist fees, materials and equipment, travel (including international travel), venue/studio rental fees, registration fees, workshops, conferences or documentation.

### **Funding Available:**

Applicants can apply for an amount between \$500 and \$5,000.

### **Applications open**

3 May 2018

### **Applications close**

27 June 2018

Applications must be submitted by 5pm (AEST) on the closing date.  
Late or incomplete applications will not be assessed.

### **Project Period**

1 Jan – 31 Dec 2019

## ASSESSMENT CRITERIA

- Quality of the program, artistic merit and rationale of the proposal
- Track record of the practitioner/s involved
- Benefit to the individual's dance practice
- Viability of the entire program and associated budget.

Applications will be assessed by an independent panel, facilitated by Ausdance NSW.

## ELIGIBILITY

- Applicants must be professional dance practitioners
- Applicants must engage with at least one Create NSW ACDP priority
- Applicants must be an Australian citizen or have permanent resident status in Australia AND have been a resident in NSW for at least 12 months preceding the application date
- Grants are not available for retrospective activities. Funds are only provided to undertake projects or activities that fall within the project period specified
- Projects undertaken to meet full time educational course requirements are ineligible for funding.
- Applicants must be a current Ausdance NSW member.

## APPLICATIONS

Applicants may discuss their applications with Ausdance NSW staff. The online applications are managed through Create NSW's secure online grants system – SmartyGrants. You must create a SmartyGrants account before you can proceed with your application.

## FREQUENTLY ASKED QUESTIONS

### What does professional mean?

Applicants must be a professional dance practitioner (dancer, choreographer, director). A professional practitioner must have a commitment to arts/cultural work as a major aspect of their working life, even if this work is not the main source of their income. The term professional is intended to indicate a degree of training, experience or manner of working that allows their work to be assessed against the highest practice and standards in their relevant artform/discipline.

### Can I devise my own professional development program?

Yes – include a timetable and organise where you would like your program to take place. An example: A choreographer wanting to explore work in a new setting, might want to apply for a paid secondment within a different artform or context e.g. a gallery, film company, theatre company, digital design company, gaming company, or international company.

### What can I spend my budget on?

Anything that supports your project. You can spend your budget on: fees (yourself and mentor), travel (including international travel), accommodation, training; e.g. master classes; dance/choreography or courses: business, film editing, website design, etc.

### Supporting Material

Applicants can provide supporting documentation with the grant application. Limits to the size of files you can upload are noted on the application in SmartyGrants.

### Successful Applicant Requirements

Results of the assessment are communicated by email. Please allow at least 12 weeks from the closing date before making enquiries.

### Reporting

Grants must be expended as outlined in the application unless prior written permission to make a variation has been asked for and given by Ausdance NSW. Successful applicants must submit an acquittal report available through SmartyGrants.
